As an industrial facility located within the City of Medicine Hat, we maintain a "best neighbor" philosophy through site maintenance, tree planting, control of unwanted vegetation, prevention of dust emissions, and ensuring all on-site activities are in accordance with relevant occupational health and safety regulations and guidelines.

# <u>Sustainability</u>

We never stop working to minimize our operational impact on the environment. Our efforts are guided by and include:

- Adherence and compliance to all local, provincial and federal environmental regulations.
- Recycling as much as possible with targets on minimizing waste and landfill volumes.
- Investing in energy efficiency across all aspects of operations by implementing best available technology processes for minimizing consumption and reducing waste and emissions.
- Minimizing consumption of water and other resources.
- Continual improvement of yield to maximize carbon black recovery.
- Reducing the amount of GHG emitted per tonne of carbon black produced.
- Offsetting GHG emissions on the Alberta power grid through production of electricity from waste heat.

Since 2001, Cancarb has operated a steam generating power plant which produces electricity from the waste heat recovered from our thermal carbon black process. On average, Cancarb provides approximately 15% of the City of Medicine Hat's local electricity demand, thereby offsetting electricity that would have been produced mainly through natural gas or coal-fired generation. Consequently, when considering the Province of Alberta's electricity grid displacement factor, the waste heat electricity generation plant provides a substantial reduction in Alberta electricity grid GHG production, effectively giving Cancarb a negative GHG emission index.

# **Reliability**

As a subsidiary of Tokai Carbon Co. Ltd., Cancarb strives to meet the sustainability goals and objectives established in Tokai Carbon's philosophy "<u>Ties of Reliability</u>" with our stakeholders. The Tokai Carbon Group's management strategies are based on due consideration of Environmental, Social, and Governance impacts and we work to resolve social issues through our business activities, thereby contributing to the realization of a sustainable society as well as to the sustainable enhancement of corporate value.
